Contributions are welcome on the following subjects:

NEW DATA SOURCES - NEW COLLECTION METHODS (data acquisition)

- Using new data sources (big data, open data, administrative data, telephone data and web scraping, etc.)
- Use of new tools to collect data (e.g. questionnaire on smartphones or tablets, and crowdsourcing, etc.)
- · Combining data sources and data linkage

INNOVATIVE PRODUCTION METHODS

- Increasing the range of methods (artificial intelligence, inductive methods, modelling and blockchain, etc.)
- Automating the production process
- Combining data sources and data linkage

NEW TYPES OF PUBLICATION

- Open government data (developments and added value)
- Interactive, dynamic and modular publications

COOPERATION

- Strengthening of cooperation and coordination between statistical offices (development of joint tools and once-only principle for data collection, etc.)
- Public-private and intra-public sector partnerships (data producers and research and development, etc.)

Presentations can be given in French, German or English. The presentation must be given in the language of the title submitted.

To make the Swiss Days of Official Statistics more attractive, we have added new types of presentation. You can therefore choose from the following three options:

- a 20 minute presentation on one of the above subjects (max. 15 minutes for the presentation itself and 5 minutes for questions);
- A poster and a 90 second presentation to the assembly (1 slide; free choice of subject);
- A lightning talk to the assembly (free choice of subject).
 Definition: a lightning talk is a 5-minute presentation accompanied by 15 slides projected automatically every 20 seconds. For examples see: lightning talks UseR 2017

Please send the title and a summary of your project (max. one A4 page) with an indication of the option chosen (presentation, poster or lightning talk) by uploading the document below to the following address:
